BOARD'S FINAL ORDER

On October 14, 2009, the duly appointed Hearings Officer submitted his Findings of Fact, Conclusions of Law and Recommended Order in the above-captioned matter to the Contractors License Board ("Board"). Copies of the Hearings Officer's recommended decision were also transmitted to the parties. A copy of the Hearings Officer's recommended decision sent to Robert A. Scarpitto, dba Viking Pools Mid-Valley, Inc. ("Respondent") was returned marked "Unclaimed, Unable to Forward." Although the parties were provided with the opportunity to file exceptions, no exceptions were filed.

Upon review of the entire record of this proceeding, the Board adopts the Hearings Officer's recommended decision as the Board's Final Order. Accordingly, the Board finds and concludes that Respondent Robert A. Scarpitto, doing business as Viking Pools Mid-Vailey, Inc. violated Hawaii Revised Statutes §§444-9.3 and 17(3), along with Hawaii Administrative Rule §16-77-8(a).

For the violations found, Respondent's contractor's license is hereby revoked and Respondent shall immediately submit all indicia of licensure as a contractor in the State of Hawaii to the Executive Officer of the Board. The Board further orders that Respondent pay within sixty days of the Board's Final Order: (1) restitution to Denise Anne Matlock in the sum of \$17,630.00; and (2) a fine of \$25,000.00. Payment of the fine shall be by certified check or money order made payable to

the "State of Hawaii, Compliance Resolution Fund." Payment of restitutions shall be made payable to the complainants. Send all payments to: Regulated Industries Complaints Office, Department of Commerce and Consumer Affairs, 235 South Beretania Street, 9th Floor, Honolulu, Hawaii 96813. Payment of the restitution and fine shall be conditions for relicensure in the event Respondent reapplies for licensure following the period of revocation.
