SETTLEMENT AGREEMENT PRIOR TO FILING OF PETITION FOR DISCIPLINARY ACTION AND BOARD'S FINAL ORDER

Petitioner, DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS'

REGULATED INDUSTRIES COMPLAINTS OFFICE (hereinafter "RICO" or "Petitioner"),
through its undersigned attorneys, Respondent KD CONSTRUCTION, INC. (hereinafter

"Respondent KD"), and Respondent DANIEL G. CHING (hereinafter "Respondent Ching"),
enter into this Settlement Agreement on the terms and conditions set forth below.

AND APRIL OF CONCERNATION OF

A. <u>UNCONTESTED FACTS</u>

- 1. At all relevant times herein, Respondent KD was licensed by the Contractors Licensing Board (hereinafter the "Board") as a general contractor, with some specialty licenses, under license number CT 14956. The license was issued on or about December 6, 1988. The license will expire on or about September 30, 2010.
- 2. At all relevant times herein, Respondent Ching was licensed by the Board as a general contractor, with some specialty licenses, number CT 12383. The license was issued on or about May 8, 1987. The license will expire on or about September 30, 2010.
- 3. At all relevant times herein, Respondent Ching was the responsible managing employee for Respondent KD.
- 4. For purposes of this action, the mailing address for Respondent KD and Respondent Ching (hereinafter collectively referred to as "Respondents"), is c/o Arthur F. Roeca, Esq., Roeca, Louie & Hiraoka, 900 Davies Pacific Center, 841 Bishop Street, Honolulu, Hawaii 96813.
- 5. RICO alleges Respondents made misrepresentations on their renewal applications, failed to pay debts due and failed to report judgments, liens and/or orders to the Board. True and correct copies of the liens, judgments, and orders are attached as Exhibits "1" through "10".
- 6. The foregoing allegations, if proven at an administrative hearing before the Board, would constitute violations of the following statute(s) and/or rule(s): Hawaii Revised Statutes ("HRS") §§ 436B-19 (17) (violating licensing laws), 444-17(10) (misrepresentation), 444-17(14) (failure to pay debt incurred for service or material rendered or purchased), and 436B-16 (licensee shall report judgments within 30 days).

7. The Board has jurisdiction over the subject matter herein and over the parties hereto.

B. <u>REPRESENTATIONS BY RESPONDENTS</u>

- 1. Respondents are fully aware that Respondents have the right to be represented by an attorney and are represented in this matter by Arthur F. Roeca, Esq., Roeca, Louie & Hiraoka, 900 Davies Pacific Center, 841 Bishop Street, Honolulu, Hawaii 96813.
- 2. Respondents enter into this Settlement Agreement freely, knowingly, voluntarily, and under no coercion or duress.
- 3. Respondents are aware of the right to have a hearing to adjudicate the issues in the case. Pursuant to HRS § 91-9(d), Respondents freely, knowingly, and voluntarily waive the right to a hearing and agree to dispose of this case in accordance with the terms and conditions of this Settlement Agreement.
- 4. Respondents being at all times relevant herein licensed as general contractors by the Board acknowledge that Respondents are subject to penalties including but not limited to, revocation, suspension or limitation of the licenses and administrative fines, if the foregoing allegations are proven at hearing.
- 5. Respondents do not admit to violating any law or rule, but acknowledge that RICO has sufficient cause to file a Petition for Disciplinary Action against Respondents' licenses, and Respondents represent that the obligations related to the attached debts, liens, judgments and orders have been resolved. True and correct copies of the debts, liens, judgments, and orders are attached as Exhibits "1" through "10". True and correct copies of documents

reflecting the resolution of those debts, liens, judgments, and orders are attached as Exhibits "A" through "J".

- 6. Respondents enter into this Settlement Agreement as a compromise of the claims and to conserve on the expenses of proceeding with an administrative hearing on this matter.
- 7. Respondents agree that this Settlement Agreement is intended to resolve the issues raised in RICO's investigation in RICO No. CLB 2007-260-L.
- 8. Respondents understand that they must comply with disclosure requirements on any renewal applications which may include but not be limited to the aforementioned debts, liens judgments and orders. True and correct copies of the debts, liens, judgments, and orders are attached as Exhibit "1" through Exhibit "10".

C. TERMS OF SETTLEMENT

1. Revocation of License. Respondents voluntarily agree to the revocation of their contractor's licenses for the period of five (5) years, however, such revocations are stayed for a period of three years from the date of the Board's Final Order. The stay on the revocations shall be lifted and Respondents' licenses revoked in the event that either of the following occurs during the three year period: (a) Respondents fail to report any judgments, awards, orders, liens or other such determinations as required by Hawaii law; or (b) Respondents fail to pay fines as set forth in this Settlement Agreement. In the event the stay is lifted, Respondent shall turn in all indicia of their licensure to the Executive Officer of the Board within ten (10) days after receipt of notice that the stay has been lifted. Upon completion of the revocation period, Respondents understand that they must apply to the Board for new licenses pursuant to and subject to the

requirements and conditions set forth in HRS §§ 92-17 and 436B-21. If after the three years the stay has not been lifted, the order of revocation shall be dissolved.

- 2. <u>Administrative Fine</u>. Respondents agree to pay, jointly and severally, an administrative fine in the amount of FIFTEEN THOUSAND AND NO/100 DOLLARS (\$15,000.00) as follows:
 - 1) \$1,000.00 by May 1, 2010;
 - 2) \$1,000.00 by June 1, 2010;
 - 3) \$1,000.00 by July 1, 2010;
 - 4) \$1,000.00 by August 1, 2010;
 - 5) \$1,000.00 by September 1, 2010;
 - 6) \$1,000.00 by October 1, 2010;
 - 7) \$1,000.00 by November 1, 2010;
 - 8) \$1,000.00 by December 1, 2010;
 - 9) \$1,000.00 by January 1, 2011;
 - 10) \$1,000.00 by February 1, 2011;
 - 11) \$1,000.00 by March 1, 2011;
 - 12) \$1,000.00 by April 1, 2011;
 - 13) \$1,000.00 by May 1, 2011;
 - 14) \$1,000.00 by June 1, 2011; and
 - 15) \$1,000.00 by July 1, 2011.

Payments shall be made by cashier's check or money order made payable to "DCCA Compliance Resolution Fund" and shall be mailed to the Regulated Industries Complaints Office, ATTN: Tammy Kaneshiro, Esq., 235 South Beretania Street, 9th Floor, Honolulu, Hawaii 96813.

- 3. <u>Possible further sanction</u>. The Board, at its discretion, may pursue additional disciplinary action as provided by law to include further fines and other sanctions as the Board may deem appropriate if Respondents violate any provision of the statutes or rules governing the conduct of specialty contractors in the State of Hawaii, or if Respondents fail to abide by the terms of this Settlement Agreement.
- 4. <u>Approval of the Board</u>. Respondents agree that, except for the representations, agreements and covenants contained in Paragraphs C.5, C.6, C.7 and C.8 below, this Settlement Agreement shall not be binding on any of the parties unless and until it is approved by the Board.
- 5. No Objection if Board Fails to Approve. If the Board does not approve this

 Settlement Agreement, does not issue an order pursuant thereto, or does not approve a lesser remedy, but instead an administrative hearing is conducted against Respondents in the Board's usual and customary fashion pursuant to the Administrative Procedure Act, Respondents agree that neither Respondents nor any attorney that Respondents may retain, will raise as an objection in any administrative proceeding or in any judicial action, to the Board's proceeding against Respondents on the basis that the Board has become disqualified to consider the case because of its review and consideration of this Settlement Agreement.

6. Any Ambiguities Shall be Construed to Protect the Consuming Public. It is agreed that any ambiguity in this Settlement Agreement is to be read in the manner that most completely protects the interests of the consuming public.

7. No Reliance on Representations by RICO. Other than the matters specifically stated in this Settlement Agreement, neither RICO nor anyone acting on its behalf has made any representation of fact, opinion or promise to Respondents to induce entry into this Settlement Agreement, and Respondents are not relying upon any statement, representation or opinion or promise made by RICO or any of its agents, employees, representatives or attorneys concerning the nature, extent or duration of exposure to legal liability arising from the subject matter of this Settlement Agreement or concerning any other matter.

Complete Agreement. This Settlement Agreement is a complete settlement of the 8. rights, responsibilities and liabilities of the parties hereto with respect to the subject matter hereof; contains the entire agreement of the parties; and may only be modified, changed or amended by written instrument duly executed by all parties hereto.




